TruStage Solution Lets Credit Unions Offer Insurance Protection to More Members

60% of consumers worry about not being able to make their loan payments due to unexpected expenses. This has real ramifications for credit unions.¹

Credit unions can help provide peace of mind to members by offering to protect the member's loan payment in circumstances where the member is unable to manage expenses. These can include an unexpected repair or a total vehicle loss, unemployment, disability, or even death of an earner in a household. In fact, this year 64% of consumers indicated that, if offered, they are likely to get one or more payment protection products along with their loan. This is a significant increase from 2019, when only 38% of consumers indicated they are likely to consider payment protection products.¹

While the need is high, consumers aren't consistently offered payment protection products. Only 50% of consumers were offered payment protection products on their auto loan, and it was even less on personal loans – with only 30% of consumers being offered payment protection.¹

TruStage is helping credit unions increase awareness of payment protection products with our digital investments. Our recent survey of credit unions found that 65% of loans are starting digitally, and 10% are funding with no human intervention. Our investments are targeted at increasing member education and making it easier to purchase payment protection products through digital channels. A recent example of this is our integration with MeridianLink to enable payment protection products to be offered as part of the member's digital loan application. This consumer tested design has over 40% of credit union members engaging with payment protection products. Member interest is seamlessly transferred to the loan officer, enabling them to engage in a deeper conversation on member need and product fit. The benefit of this integration into digital channels is that members are made aware of their payment protection offers 100 percent of the time, and it allows lending staff to have more meaningful conversations regarding product fit.¹

TruStage is in the process of expanding their lending payment protection integration with credit union technology platforms across member-facing loan applications, home banking, financial wellness, and communication platforms.
